### **Establishment:**

The Govt. of Maharashtra established the Kavikulaguru Kalidas Sanskrit University on 18th September 1997 at Ramtek, which is a township in Nagpur district, and is connected with the name of great Sanskrit poet of the world Kavikulaguru (Master of all poets) Kalidas.

This is the first kind of University in Maharashtra and aims to set up a standard for others to look-upon as one of the pioneer institution and a matter of pride to the state of Maharashtra particularly in the field of "Sanskrit".

### **Objective**:

This Sanskrit University has been established to rejuvenate, cherish and disseminate the universal values, knowledge, wisdom and vision presented in Sanskrit language and literature and establishes a progressive synthesis between ancient Indian wisdom and modern scientific thought in harmony with the needs of today and tomorrow.

The University functions present and promote Indian Culture in the field of Yoga, Ayurveda, Architecture, Meteorology, Agriculture, Yogashastra, Music, Arts, Languages, Education and Comparative Literature at International Level.

UGC Recognition: The University got UGC recognition u/s 2(f) in 2000 u/s 12 (B) in 2012. NCTE Approval for B.Ed. amd M.Ed. Courses: NCTE 27/08/2008

#### Jurisdiction

The territorial limits, within which the powers conferred upon the University by the University Act shall be exercised, shall comprise the State of Maharashtra.

Provided that, the University may, subject to such conditions and restrictions as it and the State Government may think fit to impose, admit any college, institution or research centre established beyond the territorial limits within or out of India, to the privileges of the University, with the approval of the State Government and wherever necessary, the Central Government.

The University may, in the interest of learning in Sanskrit, start or conduct a college or research Institution or a Pathashala in any territory outside the State of Maharashtra, with the approval of the Government concerned.

### **About University**

Kavikulaguru Kalidas Sanskrit University (KKSU) was established on 18 September 1997. It is named to pay rich tribute to Legendary Sanskrit Mahakavi Kalidasa. KKSU is an institution dedicated to the advanced learning of Sanskrit. It is located at Ramtek which falls under Nagpur District, the second capital of Maharashtra. It is the first Sanskrit University of Maharashtra. **History of Establishment:** The former Prime Minister of India, P.V. Narasimha Rao, who is the great Scholar of Sanskrit, was keen on setting up an independent Sanskrit University in Maharashtra. With encouragement from Mr. Rao, the late CM of Maharashtra Shri S. Naik took up the issue and appointed Dr. S. Jichkar as one member committee to give a study report for establishing the Sanskrit University in Maharashtra. Dr. Jichkar prepared the study report and a non-formal University act for the establishment of Sanskrit University in Maharashtra. One of the Prominent Scholar of Sanskrit and Eminent personality of Vidarbha region Dr. Pankaj Chande was the Founder Vice-Chancellor of Kavikulguru Kalidas Sanskrit University.

The UGC recognized University with 12B & 2f status and accredited by NAAC with B++. It gives recognition to the educational institution for specialized studies in the jurisdiction of Maharashtra & Goa. It is a prominent research centre for researchers.

- ii) For late submissions of forms & other documents to University, the college authorities shall be held responsible for the payment of late fees as stipulated in this calendar.
- iii) All admission shall be provisional till the University approves them after due scrutiny of all documents of admitted students.
- iv) All the Principals of the institutions should send the list of students admitted in their colleges/institutions to the university on or before & 05-08-2016.
- v) Students admitted after the last date of admission shall not be considered for enrolment in the University and therefore, shall not be permitted to appear at the university examinations.
- vi) Original Transfer certificates, Migration certificates and Mark-sheets of the students and other essential documents should be submitted by all affiliated colleges to the University for verification before 26-08-2016 Or 30-09-2016 with late fees along with duly filled in enrollment forms with requisite fees.
- vii) All admitted students must obtain eligibility from the University before admission on payment of prescribed fee. Hon'ble Vice Chancellor will have the special power to permit an admission of eligible candidates on case to case basis within thirty days from the last date of admission.
- viii) For External Students The students should submit their enrolment and examination forms on or before 26-08-2016 The forms submitted after the due date will be fined as per the clause 5 (b) & (c).
- viii) Theory and Practical examinations will also be held on Sundays and Public holidays.
